NEW MEMBERS

OBTAINING "H"CLASS LICENCE

(later purchasing Handgun)

- A prospective new member is required to complete TEPSL's APPLICATION FOR MEMBERSHIP form and to supply the following:
 - Two character references from persons who have known the applicant for two or more years.
 - Details of firearms owned by the new member
 - Details of current membership at other Firearms Clubs.

The form along with the additional information will be tabled at the next TEPSL committee meeting for approval.

- New Member and TEPSL representative (Club Captain or Secretary) complete SUPPORT OF APPLICATION FOR <u>PERMIT</u> TO USE CATEGORY H FIREARM UNDER SUPERVISION (PF474A). New member submits PF474A to NT Police. At police station new member completes an APPLICATION FOR <u>PERMIT</u> (PF444).
- 3. When New Member is in possession of their permit, the training period commences. The training constitutes 12 training sessions over a minimum period of 12 weeks.

Note: Even when a new member has been passed by the club as competent, NT police will not issue a full license until the 12 week probationary period has been fulfilled.

- 4. New member and TEPSL representative (Club Captain or Secretary) complete SUPPORT OF APPLICATION FOR CATEGORY H SPORTS SHOOTER <u>LICENCE</u> (PF474B). New member submits PF474B to NT Police. At police station new member completes an APPLICATION FOR <u>LICENCE</u> (PF444); same multipurpose form as above.
- Member must wait six months before being able to apply for his/her own handgun. Member and TEPSL representative (Club Captain or Secretary) fills in APPLICATION TO PURCHASE CATEGORY H FIREARM (PF474C). Member submits form at police station.

- 1. Complete all sections of the form
- 2. All members are required to complete a new form each year
- 3. Current members do not require Proposer/Seconder signatures
- A description of membership types is detailed below

Full Member

Above 18 years old and is a holder of a H class shooters licence; must attend four working bees per year.

Junior Member

Less than 18 years on 1 July. Has voting rights and should attend *two* working bees per year. Pays 50% of Full Membership fee.

Senior Member

Be 65 years on 1 July. Has voting rights and should attend two working bees per year. Pays 50% of Full Membership fee.

Associate Member

Shooter who holds full membership at another Pistol Club or a person with a current firearms licence other than category H Class. May not be elected to the TEPSL Committee and has no voting rights. Must attend *two* working bees per year. Pays 50% of Full Membership fee.

Social Member

Member of the public with no shooters licence of any type. May not be elected to the TEPSL Committee and has no voting rights. Not required to attend working bees. Pays 50% of Full Membership fee.

Life Member

Life Member is entitled to all privileges of membership without paying annual fees and not required to attend working bees. [Key to the TEPSL range; member is required to complete and return membership form].

Family Membership

Available where one member holds Full Membership and has up to three dependents, capped at four persons per family membership.

Spouse and/or dependant/s* that reside at the same address as of the Full Member; enjoy the same privileges as Full Member. Family membership capped at 150% of Full Membership for a Family of four persons.

*Dependant is a person under 25 year of age, living at the same address as the Full Member and not employed in full time work. If a person is in full time work, they are not considered a dependant.

Corporate Fee

Decided by TEPSL Committee on a case by case basis.
