• **Full Member**

Above 18 years old and is a holder of a H class shooters licence; must attend *four* working bees per year.

• **Junior Member**

Less than 18 years on 1 July. Has voting rights and should attend *two* working bees per year.
Pays 50% of Full Membership fee.

• **Senior Member**

Be 60 years on 1 July. Has voting rights and should attend *two* working bees per year. Pays 50% of Full Membership fee.

• **Associate Member**

Shooter who holds full membership at another Pistol Club or a person with a current firearms licence other than category H Class. May not be elected to the TEPSL Committee and has no voting rights. Must attend *two* working bees per year. Pays 50% of Full Membership fee.

• **Social Member**

Member of the public with no shooters licence of any type. May not be elected to the TEPSL Committee and has no voting rights. Not required to attend working bees. Pays 50% of Full Membership fee.

• **Life Member**

Life Member is entitled to all privileges of membership without paying annual fees and not required to attend working bees. [Key to the TEPSL range; member is required to complete and return membership form].

• **Family Membership**

Available where one member holds Full Membership and has up to three dependents, capped at four persons per family membership.

Spouse and/or dependent/s* that reside at the same address as of the Full Member; enjoy the same privileges as Full Member. Family membership capped at 150% of Full Membership for a Family of four persons.

**Dependent is a person under 25 years of age, living at the same address as the Full Member and not employed in full time work. If a person is in full time work, they are not considered a dependent.*

• **Corporate Fee**

Decided by TEPSL Committee on a case-by-case basis.
